That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour laws etc. With respect to the school and staff of the school.

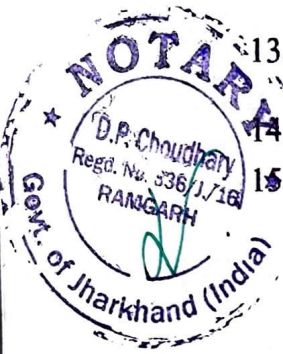
